Part II. Self-Assessment

The Town of Berkley has completed the required self-assessment and has determined that our municipality is in compliance with all permit conditions, except for the following provisions:

Due to continuing concerns regarding other priorities for Town spending, the Town was unable to implement all the elements of the Storm Water Management Program by the expiration date of the first permit term, including Year 14 of the program. Specifically, the Town has not explicitly completed the following requirements:

Failed to fully develop an illicit discharge identification program per BMP No. 3-3. In 2014 the Town continued the process of identifying priority areas for potential IDDE activities. In 2015, the Town applied for Asset Management grant funding, which would allow the Town to further advance the IDDE program; however, the grant was not awarded. The Town remains hopeful that further grants may become available to assist in the work.

The Town completed mapping of all town-owned outfalls and structures (100%). During June 2013, approximately 80 outfalls were located using GPS and another 620 manholes, culverts and catch basins were mapped. This represents about 50% of the Town. When combined with the mapping completed during the prior reporting periods, it was estimated that more than 90 % of the Town's MS4 had been mapped. During Year 13, the remaining 10% of the system was mapped.

At the Town Meeting held in June of 2017 the Highway Department obtained \$5,000 for stormwater management which will be used to continue MS4 permit activities. The Town will coordinate with their consultant to develop a scope of work. Scope items may include development of a written IDDE program, development of a written Stormwater Management Program (SWMP), updates to stormwater ordinances/regulations, or development of SWPPPs for town owned facilities. The Town remains concerned with many of the new requirements under the Final Permit especially regarding the IDDE program requirements. The Town has a very limited potential to significantly impact water quality, due to its extremely low Impervious Area, low population density, and a lack of commercial/industrial facilities. We remain cautious about the permit as there could be significant costs to the Town resulting in no water quality improvements.
