Year 1

Basin Inspections list is being compiled and will be integrated into the mapping phase of our Plan. Details will include if there was an illicit connection, type, condition, oil trap condition if present, dates cleaned, etc..

No other data to report at this time.

Year 2

Nothing new to report at this time. No illicit connections have been discovered during repairs, inspections and cleanings.

Year 3

All location of known manholes, basins, and outfalls have been GIS located and added to our base map system. No illicit discharges were located during mapping and inventory. Several LID workshops and public hearings and New LID and erosion control Bylaw have been approved at Town Meeting to encourage open drainage and LID. Several old as well as new videos were shown on local access channel relative to storm water as well as television interviews with Planning Administrator and Highway Surveyor relative to LID. Town wide mailing of river awareness flyers cosponsored by Nashua River Watershed Association

Year 4

Major components of permit complete.

Information left to obtain for species habitat is forthcoming.

Year 5

See Self assessment for new accomplishments.

Waiting to hear for federal listed species.

Year 6

Continue public education

Update rules and regulations as needed

Year 7

The major components of the EPA storm water grant have been completed, because we saved money and were under budget, we have money for an additional project.

BMP's for ditch cleaning established in house to be consistent town wide.

Updating bylaws and regulations as required, most were in place prior to permit.

TMDL recommendations received and plan for updating is in process. Most of the recommendations have been in place prior to report.

Year 8

Major goals of the permit goals have been completed. Maintenance items ongoing and done as routine work are geared to enhance the aspects of this plan. Hazardous waste training this summer for staff to recognize problems.

New IT personnel on board to help enhance GIS mapping and new web based program to make access to maps of stormwater infrastructure easier. Stream teams monitoring with NWRA quarterly on select water ways.

New members of Stormwater committee appointed that may have new ideas for enhancement of program now on board Awaiting new regulations for continuation of program.

Year 9

Maintenance items in plan continue. Upgrading and cleaning of our system is our priority. Conversions, cleaning and retrofitting of basins with oil hoods is new goal. Hazardous waste center operational as well as regional recycling center and efforts being made to increase use of both. Continuing to work with NWRA and stream teams for cleanings and monitoring. Updating Master plan to encourage LID techniques in new developments.

Year 10

Routine items that are in place are continued. Conservation Commission reviewing bylaw for any changes. Our engineers are looking at new 319 grant for low impact improvements. Local stream monitoring teams working with NRWA collecting and reviewing data to monitor hot spots. New town website will make permitting and informing public easier and more accessible. New strategy of removing catch basins where they are redundant and in areas where LD methods can be deployed.

Year 11

Cpa funding approved for bank stabilization on shore line of town beach area, to stabilize and stop erosion into lake, 110k. Closed drainage systems on roads being resurfaced are being aggressively scaled back or eliminated. New additions to wetland bylaw adopted at town meeting will help the permitting process with clearer language. Two new developments as well as 1 redevelopment utilizing lid techniques instead of conventional drainage; this is in part of our bylaws

Year 12

Routine Maintenance continues with MS4 system. Storm water regulations just revised by Nitche engineering, reviewed and adopted by storm water committee April 2015. One set of regulations now being used between Storm water, planning and conservation. CPA town beach erosion project complete. NWRA to increase stream project and Town will remove collected materials.

Year 13

We continue to monitor and update our program. Awaiting new permit to implement new additions. Second recycling dumpster added at school.

Year 14

Continued to implement strategies of storm water program. Updates in current bylaws have been implemented and a minor concerns addressed. Visual Inspections of first LID systems two years ago show little or no maintenance required, great news for new open system designs. Updating of housekeeping plans for DPW in progress.

Year 15

Continue with program and start to prepare for new permit application. JNEI engineering to help update storm water bylaws this year. App Geo updating one subdivision to GIS. Two new LID subdivisions accepted by town. DEP grant enhanced recycle awareness and participation. Town wide roadside cleanup 2018 complete. New dumping bylaw adopted in 2017 town meeting. School educating class rooms on recycling.
