Historically this has been tracked by the institutional knowledge and were prioritized based upon that information. The Town began tracking catchbasin cleanings via Peoples GIS Software on 11/22/2019 to help

track and prioritize our catchbasins. We continue to work towards this digital transition and are confident that this will help us prioritize problem catchbasins.

While the Town has determined which outfalls we believe to be in the MS4 area, we have not made a determination on which catchbasins are jurisdictional. In addition many of the catchbasins in Town are Leaching basins which do not discharge to a waters of the US.

The Town is working with the Buzzards Bay Coalition under a 604B grant to monitor the Benthic Habitat of Red Brook Harbor which is an impaired waterbody without a TMDL.

We have also applied for additional grant funding for loading analysis and hydrodynamic modeling of Red Brook Harbor however we have not heard whether the Town received this grant,

The Town is working with the Cape Cod Conservation District and the USDA Natural Resources Conservation Service to secure funding for stormwater improvements in the areas of Hen Cove and Monks Park.

Public Outreach: It became almost impossible to educate the public and supply informational materials due to the pandemic using our traditional methods and due to the suddenness of the pandemic we were not prepared to shift to all digital methods.

Development of inventories: Town staff & Offices were shutdown for several months and the collaboration required to inventory and document these site was difficult. The Town is hiring a new DPW director and he will consult prior to issuance of O+M procedures.

IDDE: The Town had an MOU with MA Maritime University to perform a discharge inventory and outfall sampling beginning in Spring of 2020 however the school and all its programs shut down due to Covid, and could not begin on schedule.
