Because of delay in the City Adopting the Stormwater Ordinance as previously communicated, we were not able to start the implementation process when COVID 19 intervened and stopped the process. We are now in the process of gradually staffing the Stormwater Management staff. Employee training is yet to start.

We have during there view process ensure that they are designed in conformance with the Ordinance requirements. We do not have the staff for field inspection at this time, but all the ones that meet EPA threshold, also require Wetlands permit. We rely of the capable Wetlands Director to perform the Construction monitoring.
