Items not completed above were due to Covid-19. The City of Chicopee operated on a reduced staffing basis with no open offices from March through June. Without the full staff working at every department, programs were unable to be developed as full participation was not possible in the reporting year.

Emergency spill procedures and notifications are posted throughout all DPW facilities. DPW senior staff who participate in snow removal are trained on proper salt and chemical storage annually.

All permit requirements not completed during year 2 were a direct result of Covid-19 restrictions. With limited staffing from City employees and our consultants, there was difficulty in completing outfall screenings, inventory of assets, drainage area delineations, catch basin inventory, catch basin cleaning, and IDDE requirements.
