Message Description and Distribution Method:

Distributed brochure, reusable shopping bags and grippers with stormwater info printed in/on them at Annual Lion's Arts Festival. Brochure defines stormwater runoff; why runoff is a problem; effects of pollution; ways residents can help prevent stormwater pollution; lawn & garden maintenance; pet waste; septic systems maintenance; hazardous waste; auto care; clean up of spilled fluids; other debris such as plastic bags; and proper disposal of hazardous materials. Spring event not held due to pandemic.

We held a hazardous waste collection day on 6/13/20 and made public announcements about this event months in advance even though we were dealing with the pandemic. Public response was good.

Approved policy requiring stormwater messages on storm grates.

Installed new drain grates on broken drains and are using on new installations with message that says, "DUMP NO WASTE! DRAINS TO WATERWAYS" to remind the public not to put pollutants into storm drains.

Developed and implemented use of New Permit with accompanying Inspection Record.

Our mapping system is still a hand-drawn, hard copy. Still plan to put it on computer using appropriate software and EXCEL spreadsheet. During reporting period, an admin. assistant was hired for the Supt. of Streets to help with reporting and record-keeping requirements. Her work hours for FY21 were increased because she is working with Planning and Zoning Boards to identify structures in existing housing developments built before the Stormwater Committee was formed, and the SWMP and IDDE were required.

COVID-19 Impacts

Comments concerning the affect of COVID-19 are scattered throughout this report in relevant places. In compliance with the governor's orders, all non-essential buildings were closed and non-essential personnel either worked from home or some were laid off. It should be noted that all essential town services were provided, some on a limited basis. Public response to stormwater issues or documents was very limited or non-existent. Stormwater maintenance including road sweeping, catch basin cleaning and inspections were conducted. All site inspections and any enforcement actions were completed. The Stormwater Committee (SWC) met on a regular basis using the Old Town Hall because distancing was possible. The chairman of the SWC attended all Zoning Board Hearings concerning a proposed large 40B development; said hearings still taking place due to a number of questions concerning environmental issues including stormwater management.

Due to the uncertainty of the pandemic and further lifting of restrictions, we plan to complete any items not finished in 2020; prepare report on and implement green infrastructure recommendations; prepare report and implement recommendations on impervious cover - street design and parking lots. In addition, we plan to acquire a new street sweeper; use some of the additional hours for the Highway Dept's administrative assistant for work on MS4 reporting requirements; get approval and funding for a combination stormwater and conservation commission agent; continue involvement with the hearings on the proposed 40B development and work closely with the Conservation Commission relative to this development.
