Due to the updated 2016 MA DEP 303(d) list, Lexington was just included in the Cambridge Reservoir Chloride impairment. We will begin updating our SWMP and working on a Salt Reduction Plan.

The town is working with a consultant to perform several catchment investigations starting in Permit Year 3 to keep on track for completing all catchment investigations within 10 years. First catchment investigation was started last year and is nearly complete but access to a couple of houses is required to perform dye testing to determine presence of illicit discharge but due to COVID have been unable to schedule these actions. Erosion and Sediment Control contractor and builder training was started in January of 2020. This training was held in person until Covid protocols required electronic, email changes. These trainings consisted of a PowerPoint presentation showcasing proper erosion controls on construction sites and examples of good and bad sites from properties in Lexington. This program is focused on sites below one acre of disturbance but still requires all applicants that want to pull a trench permit to complete this training. This program also implemented written warning notices to construction sites that did not meet our requirements for erosion controls. 13 notices were handed out this permit term and all sites have come back into compliance.
