Due to COVID-19 safety concerns our site inspections for the DPW/Water Department Facility and Green Recycling and Compost Area were delayed and performed on August 12th, 2020. Final review and certification are planned for Permit Year 3.

Due to COVID-19 restrictions, the IDDE Training scheduled for Permit Year 2 had to be redesigned and recorded to be accessed on-demand in small groups without the trainer present. Training did not occur until September 2020 (4 DPW employees were trained).

Mansfield's NOI listed receiving waters based on the water quality limited waters within the Town's urbanized area that were included in the 2014 303(d) List. The Town has evaluated changes to the impairments and/or receiving waters based on the final 2016 303(d) List and enclosed the analysis herein. The enclosed document will be included in the Town's SWMP. Based on this review, it was determined that the requirements of Appendix H, Part V for solids are no longer applicable to Mansfield because the turbidity impairment for Norton Reservoir (MA62134) was included in the NOI for non-direct MS4 discharges to the waterbody in error. In accordance with Appendix H Part IV.3.b., the Town will document in the SWMP the date of this determination and date of EPA concurrence.

During Permit Year 2, the Town has modified its outfall mapping due to outfall investigation field work. 10 outfalls were removed from the MS4 mapping and will be recategorized as a different structure (e.g., culvert, BMP inlet) or removed because they did not exist. These modifications did not add or change any receiving waterbodies or impairments/TMDLs listed in the NOI.

Mansfield completed some dry weather screening of outfalls and interconnections at the end of Permit Year 2. The data included in the annual report from this permit year should be considered draft as it is being finalized by the Town's consultant. The Town continues to implement its IDDE Program and complete dry weather outfall screening in accordance with the General Permit schedule.

Updates to the stormwater regulations were planned for Permit Year 2, however due to delay in the MA Stormwater Handbook updates and the Small MS4 General Permit revisions, the Town plans to complete

these updates in Permit Year 3 to meet MCM4 and MCM 5 updated requirements.

COVID-19 Impacts

The Town planned an in person training for applicable staff on the IDDE Program during Permit Year 2 but was delayed because of COVID-19 safety concerns. Instead, Town staff completed a virtual IDDE refresher training program in September 2020.

The Town planned to complete site inspection and SWPPPs for the DPW/Water Department Facility and Green Recycling and Compost Area in Permit Year 2 but COVID-19 safety concerns delayed inspections until August 12th, 2020. Final review and certification are planned for Permit Year 3.
