As stated in the Massachusetts 2014 List of Impaired Waters, both the Charles River and Bogastow Brook are impaired for pathogens. Since the publication of the Massachusetts 2016 List of Impaired Waters, the Bogastow Brook now includes E. Coli sampling in addition to fecal coliform sampling (Millis SWMP Section 6.1.2). Outfall information will continue to be updated as the stormwater infrastructure map is updated and inspections are completed.
