COVID-19 prevented the deployment of an asset management system or other method to track the depth of sediment in catch basins during the spring when basin cleaning was taking place, due to the Town Engineer working from home. This will be rectified in Year 3, Spring 2021.

COVID-19 made coordination between DPW Engineering and the School Maintenance Dept difficult, delaying the development of a complete inventory of Town assets as required. Development of this inventory and the associated SOPs will be completed in Permit Year 3.


