We are in a revision in terms of our mapping system right now. We have made progress over the years using our mapping provider called PeopleGIS. However, our MS4 CMRSWC coalition will no longer pay for that service. Currently, we are making progress with having our system data transferred over to another provider

and they are assisting us with updating our map. Moreover, they will take our IDDE and we will work together to continue the catchment mapping and investigative work. Employees involved in the IDDE program attended training workshops sponsored by CMRSWC on May 5, 2020 and/or May 7, 2020 remotely via Go to meeting. The workshops were originally intended to be in person but were adapted to virtual workshops due to covid-19. The workshops trained participants on important aspects of the IDDE program, including how to recognize illicit discharges and SSOs. Our municipality is a member of the Central mass regional stormwater coalition (CMRSWC) and our coalition was awarded an Environmental Merit Award from EPA Region 1. Each participating community including Sturbridge, was recognized as part of the award. The award was presented in September 2019.

We will resume our catchment delineations and mapping as well as inspections on our key junction structures. Also we will keep on looking for illicit connections. Moreover, we have some drainage work planned on a few of our roads that will give us the chance to implement some BMPs. Our coalition usually provides training so we would like to send some key personnel for Ms4 training. Additional work will be to start our O&M plans for town owned facilities and inventory facilities.
