COVID-19 staffing limitations delayed completion of some permit requirements:

-The Town of Westborough has incorporated post-construction management requirements within the written

Stormwater Management and Erosion Control Bylaw to reduce pollutants in stormwater runoff discharged to the municipal drainage system from post construction activities for all new development and redevelopment sites greater than one acre, but needs to update the bylaw to require as-builts and ensure long term operations and maintenance. Westborough plans to complete this update in FY21. The Conservation Commission typically requires as-built plans and a long-term operations and maintenance plan as part of its permit reviews as well.

-Westborough has developed a draft O+M plan and facilities inventory, and will finalize in fall 2020.

-Westborough has developed a draft SWPPP for the DPW facility, and will finalize in fall 2020.
