In addition to brochures on Town website, two messages have been sent to the general public and two are to be sent business messages to contractors and developers out in Year 4. There is no industry within the MS4 region. A second questionnaire was sent out with the September 2020 tax bills with provisions for both paper and digital response. The paper response indicates a good awareness of homeowners potential influence on stormwater quality but less knowledge on the MS4 program.
