All known outfalls, stormwater BMPs, catch basins, manholes, and receiving waterbodies with impairments have been mapped to date. Initial catchment delineations have also been completed based on topographic mapping and available stormwater system information, and are being refined as additional field information is collected during catchment investigations. The Town is currently working towards completing pipe connectivity. Mapping of open channel conveyances and interconnections with other MS4s (e.g. DOT) is ongoing, and it is expected that this will continue as part of DOT's own mapping efforts to be completed under a future TS4 permit. The Town is also working to identify data gaps in its drainage mapping (e.g., catch basins without piping, disconnected drainage networks, etc.) and is actively mapping and investigating these. Any new infrastructure discovered through this process will be mapped and screened as necessary by the end of Year 10.

North River Collaborative: Space for large BMP on southern grassed part of parcel. Can install additional catch basins in parking lot and create drainage connections between all existing and proposed basins to outfall to a BMP, allowing for treatment of all runoff from parking area.

Woodsdale Elementary School: Install catch basins in the other parking areas and on either side of the basketball court. Construct a BMP in the grassed island west of the school and tie in proposed catch basins.

Plymouth Street Baseball Field: Construct BMP along fence line of baseball field to treat runoff that currently pools up there. Look into existing drainage networks that outfall in southern part of parcel to investigate potential to retrofit these networks into proposed BMP.

Beaver Brook Elementary School: All parking areas could potentially become pervious pavement, but this could be costly. Potential to install multiple BMPs (swales, rain gardens, etc.) around the school, specifically along the northeast entrance, southeast corner, and in the grassed area on the western side of the school. Would also install additional catch basins in parking areas to capture runoff.

Senior Center & Dog Park: Install a series of catch basins on the eastern and southern side of the property. This drainage system can discharge into a BMP constructed in the grassed area west of the Pickleball courts. Additional catch basins can be installed within the northern parking lot and tie into the existing catch basin to capture additional runoff.

Additionally, the Town's consultant has completed final design for BMPs at the following two sites, with construction anticipated to occur during Year 8:

- Town Hall: retrofit an existing stormwater BMP to provide enhanced treatment and install a raingarden.
- Arnold Park: install a new stormwater BMP to treat runoff from nearby roadways.

- Review as-built drawings for new and redevelopment to ensure compliance with post construction

- bylaws, regulations, or regulatory mechanism consistent with permit requirements
- Inspect all permittee owned treatment structures (excluding catch basins)
- Identify additional permittee-owned properties that could potentially be modified or retrofitted with BMPs to reduce impervious areas so that the permittee maintains a minimum of 5 sites in their inventory, until such a time when the permittee has less than 5 sites remaining
