Street Sweeping - Every road is swept at least twice per year. Main Street Business District is swept at least 3 times per week. Additional daily sweeping is completed at various high priority locations.

Structural BMP - The Town has identified a number of potential implementation opportunities and locations to construct a stormwater BMP. However, due to budgetary limitations, no properties have been modified or retrofitted with BMPs to date.

BMP Pollutant Removals - The Town has developed an inventory of town-owned structural BMPs which are inspected annually and maintained as needed. In Year 7, the Town calculated phosphorus removals provided by these BMPs.

Street Sweeping - Every road is swept at least twice per year. Main Street Business District is swept at least 3 times per week. Turbidity impaired watersheds were not observed to accumulate more sediment and debris than other areas within the Town, therefore the current sweeping schedule is deemed adequate.

Catch Basin Cleaning - Catch basin cleaning is performed in accordance with SOP PW-20-004 Catch Basin Cleaning and Inspection. The Town uses a Stormwater Operations Dashboard field app to track catch basins as they are cleaned. Based on these cleaning records, the Town has identified and prioritized several catch basins for more frequent cleaning, which it implements as part of its program.

All known outfalls, stormwater BMPs, and receiving waterbodies with impairments have been mapped to date. The Town has also substantially mapped all known stormwater infrastructure, including catch basins, manholes, pipes, and other miscellaneous infrastructure.
