There is one structural BMP in the MS4 area which is a dry well that overflows to a Stormceptor WQ device) that is 6" diameter and 4' deep. The amount of Phosphorus removal from this device and into Country Pond. Phosphorus removal from this BMP is insignificant compared to the overall watershed area..
