ADDITIONAL INFO: Mayor A. Ralph Mollis will be joined by Senators Jack Reed, Lincoln Chafee, Congressman Kennedy, and Ira Leighton, Deputy Regional Administrator New England EPA to cut the ribbon at the newly reconstructed Allendale Dam.

The Allendale Dam has been in disrepair since November 1987 when a breach in the dam occurred. The Town of North Providence, since then, sought funding assistance to have the dam repaired. It was not until the Centredale Manor Restoration Project was underway that federal funding was made available.

EPA is addressing the river as part of the Centredale Manor Restoration Project. The clean up and restoration of this phase of the project is being conducted by Loueiro Engineering on behalf of several responsible private parties, with oversight from EPA, RI DEM and the U.S. Army Corps of Engineers.
