### Proposed Cleanup Plan Amendment Hearings

EPA has issued a Proposed Cleanup Plan Amendment for the cleanup of dioxin at the Centredale Manor Restoration Project Superfund Site. Dioxins are toxic chemicals that naturally exist in the environment and can be released into the environment through forest fires, backyard burning of trash, certain industrial activities, and residue from past commercial burning of waste. In order to use the best and most current science available, EPA is proposing to use the new dioxin toxicity value to revise the Centredale Manor Site human health risk assessment and cleanup levels.
