In regards to E.P.A's diopin clean up plan wins Local Praise issue thank God. and when it comes to Pollution and Hazardous I received many letters of recognition from our highest in defense and our Perigion, this alone tells me one thing, I got good response from our highest in our nation on many points of interest, and an honor for me and partner whom passed away this past year who did all my typing without any mistakes, and claim person for Trinit and allstate insurance for over thirty years, and often quoted to me you got to be careful in what I say when anything in word form could be held against me. and quoted I dont want to get involved with our local issue in regards to our human made issue ~~rather~~ that blame factories and many things of our past for our Diopin so heavy in our centudale area and area near Johnston when we can assume it flows down toward ^{ONLEY VILLE} and into Providence and into our Bay of salt water; know as Narragansett Bay. I would always quote our army Corp of engineer could clear all our rivers out

2 in our state in short span of time, with the equipment they have including all grass in dry areas and other forms of weeds, that is getting all our ponds we have left, and mentioned this to celona a number of years back when he was Councilman in area we both reside in. The people are disgusted in many areas of our north Providence districts, very similar to Johnston area where our garbage goes that must be known nation wide, and called Johnston Sandfill as we all know, and millions of tires taken there for a small fee you can assume, that became a scary issue state wide in case some^{one} set these tires on fire, that would pollute our main source of water know as Situate Reservoir our main source of water for Rhode Islands people. yet strange as it may seem millions of sea gulls, that would fly many miles ^{to eat} our garbage were too full to fly back after eating all day and chose Situate Reservoir, to get away from other animal and rats that comes during evening ^{hours} while they rested upon ^{our} drinking source of water, yet close by to get their next meal, along with thousands of geese you can assume. that rest upon our lakes and ^{ponds} ~~ponds~~ in which we have many.

Immersion would limit dioxin removal, EPA study says

■ Raising the water level in the Allendale Pond would cover much of the tainted soil, reducing the amount that would need to be excavated.

NORTH PROVIDENCE — The U.S. Environmental Protection Agency is recommending a novel way to deal with a daunting amount of dioxin-contaminated sediments along the banks of the Woonasquatucket River.

Don't remove them, the agency says: Submerge them.

A key feature of the EPA's plan to clean up the Superfund site is

restoration of the breached Allendale Dam, allowing the pond it holds back to return to historic levels. The rise in water would cover a substantial amount of contaminated soil now exposed near a residential neighborhood.

The EPA would excavate the dioxin-tainted sediments left above the surface of Allendale Pond — as well as those downstream from the

degreaser that was likely used by area companies. One well contains carbon tetrachloride, which is used in cleaning fluids and can cause liver and kidney damage, according to the Agency for Toxic Substances and Disease Registry, a branch of the U.S. Department of Health and Human Services.

The digging will begin shortly and will be performed by R.E. Chapman Co. of West Boylston, Mass. The town will pay \$29,740 for the procedure.

"We've located three large properties on which the owners have stated they'd allow us to do some testing," said Town Engineer David Provonsil. "If this test drilling does not find any adequate locations [for a community well], then it's back to the drawing board."

If, on the other hand, the contractor finds an adequate site, then a proposal could be brought before the Town Council and eventually voted on by residents.

"We would have to find the funds to make that work," Provonsil said, referring to the possibility of creating a community water supply for the Danielson Pike homeowners who have contaminated wells.

The cost of such a water supply would vary by location, but Provonsil estimates it would be between \$250,000 and \$1 million.

Another plume of TCE contamination exists in 14 houses along Byron Randall Road, Shun Pike and Peck Hill Road in Scituate and Johnston.

The U.S. Environmental Protection Agency is currently overseeing and funding a \$250,000 pipeline extension in that area that will allow residents to access municipal water from a Johnston duct owned by the Providence Water Supply Board.

The Providence Water Supply Board owns the Scituate Reservoir, which provides water to some 60 percent of the state's residents, but the town does not receive water from it and does not have a municipal water supply system. *YOU CAN UNDERSTAND*

The EPA has not expressed an interest in helping to remedy the Danielson Pike contamination.

Frank Gardner, the EPA's on-site coordinator at the Byron Randall Road site, noted that the Danielson Pike residences are — unlike the Byron Randall houses — "a great distance" from a municipal water source. *MANY SPRING FOR MILES*

"It's a much more complicated and sort of long-term problem," he said. "On Byron Randall Road, the source of the contamination has been identified. We don't have any of those pieces [with the Danielson Pike homes]."


Dear Mr. Pickering:

Thank you for your letter of November 6 to Secretary Cheney concerning your Automobile Exhaust Gas Cleaner.

As much as he would like to, Mr. Cheney cannot reply personally to every communication he receives. Therefore, he has asked the departments and agencies of the Department of Defense to reply on his behalf in those instances where they have special knowledge or special authority under the law. For this reason, your communication was forwarded to officials of the Department of the Army.

I have been asked to respond to your comments and concerns, and hope that I do so to your satisfaction.

My office is not able to evaluate, from the technical aspect, the potential application of your product to our ground combat systems. However, I can refer you to the responsible agency. I recommend you communicate with the U. S. Army Tank-Automotive Command as it is the Army proponent for the equipment you have proposed. 
Dear Mr Pickering,

Thank you for writing to express your concern on air pollution, and for showing me your inventive patent to reduce sludge and ash release from incinerators and automobiles.

Please be assured that I am continually working towards environmentally sound legislation. To this effect I support the Clean Air Act (CAA), S. 1630, recently passed in the Senate and, if passed into law, will help combat future air pollution. A strong Clean Air Act is vital to protect the health of our citizens, and safeguard our valuable national resources. I remain committed to eliminating the great damage inflicted by acid rain, air toxins, and ground level ozone. The time for studies and information is long overdue; the time for action is now.

The Clean Air Act regulates air toxins, limits low level ozone, and seeks to curb acid rain. As part of S. 1630, I introduced an amendment designed to reduce emission levels of sulfur dioxide, nitrogen oxide, and carbon dioxide, the three main pollutants responsible for acid rain, ground level ozone, and the greenhouse effect. This amendment was incorporated into the final version the CAA which was passed in the Senate. Rest assured that my commitment to environmental protection remains strong and that I will continue to actively support and introduce measures, that will effectively protect the environment.

Just beyond this force point of this crossover pipe, the condensing unit is located with jet spray nozzles arranged to work with the law of gravity to condense all types of floating pollution, such as, ash, carbons, smoke, etc., into the sludge well that would normally have escaped into the atmosphere through the smokestack.

Some of our greatest health problems today are because the means of trash disposal and burning are inadequate, and defies the balance of power needed to desperately enhance the situations at our landfill sites.

There are many pros and cons of both the recycling and the incinerator processes.

In fact, the profits from recycling could be utilized to build a "smokeless incinerator" to burn our excess garbage and hazardous waste that are definitely pollutants, which are "polluting our drinking water and our atmosphere".

As previously stated, I have obtained patent rights for the "smokeless incinerator" which contains a "water cooled, heavy duty crossover pipe" for regulating degrees of heat that could burn pollutants, such as lead paint from wood, mercury components, etc., and kill

all types of bacteria, and would not be emitted to the atmosphere and also would not be exposed as "horror stories" about pollution.

All these types of pollutants and ash components, similar to the eruption of Mt. St. Helon, are condensed and transmitted to the "sludge well", and either sold or given away. In a few words, I would like it shown why our pollution device is so costly, and prove with logical explanation, as I have an air pollution device made in reference to "Mother Nature".

Our crankcase oil fumes are made by friction of moving parts of the engine. Oil is used as a cushion, so bearing surfaces don't wear out. Yet these oil vapor mist fumes are highly explosive, if not removed from the internal parts of the engine. Today the PCV Valve is used to draw oil vapor fumes from the engine, and has a small ball check in this line to your carburetor. The principal of the ball check is good, because any backfire, which takes place many times, would create another explosion within the engine by oil vapor fumes in the crankcase and rocker box cover area, and would possibly destroy your new engine completely, if the ball check wasn't installed.

These fumes are brought into your carburetor now losing six or eight miles on every gallon of gas you use, and also effect the efficiency of your car.

These are oil vapor base fumes. Now we are moving into another type, the very hot exhaust manifold gases which are mostly dry from exhaust

valves into your castiron manifold which is extremely hot. Now comes another problem.

Remember there are two types of fumes now being delivered into your CatalyticConverter. The emense heat from engine is now being delivered through the exhaust manifold into the converter and through the muffler and into your tailpipe, causing a very high acidity rating, plus forming of carbon particles which tends to wear out exhaust systems much quicker today.

This isn't the answer I am looking for.

→ Our pollution devices are destroyed even without you knowing it all the time. How? Remember, the air pollution device that is installed on your car which you paid so dearly for which has charcoal pellets to absorb pollution from the exhaust system while passing through this system. Think again, now what is most logical thing you can foresee. Extreme heat from the manifold will ignite these charcoal pellets. "What happens next?" Don't open the CatalyticConverter. It is now burnt out. Many auto fires have been caused by this system, and it is now easy to understand why. This is a factory sealed-in unit, tied in exhaust system, and as I mentioned before, this charcoal turns back to ashes, the same as your charcoal on a barbecue, and it will only be added with the rest of floating pollution, because it will also be blown through exhaust system with normal exhaust. Now you have only theCatalytic Converter housing left, for which you paid \$350.00 to \$500.00 for when you purchased your new automobile.

Remembering, our pollution rate is growing rapidly. There is approximately 400,000 cars to every large industrial furnace.




