Dear Senator Chafee:

I am writing regarding the Allendale Dam Repair Project in North Providence, Rhode Island. On June 12, 1998, Mr. Bocchino of my staff met with Ms. Janet Coit of your staff and local officials. A great deal of concern was registered regarding the scope of the Federal project. This letter is to provide a status report and apprise you of our plans.

The Dam was naturally breached in 1991 when its wooden crib failed. The Town of North Providence hired a consultant who prepared plans to repair the breach and estimated the construction cost at \$90,000. This project scope and its estimate was the basis for the project's first authorization at \$90,000 in the Water Resources Development Act (WRDA) of 1994 directing the "reconstruction" of the Dam. Upon initiation of Corps efforts, it became clear that the \$90,000 estimate was low and that construction at that estimate was not possible. In coordination with our Headquarters and your staff, we prepared revised draft plans and specifications to repair the breach within available funds and provided them in 1995 to the Town for its use, with the recognition that NEPA and other appropriate regulatory requirements would need to be satisfied before beginning repair.

The project was later re-authorized at \$350,000 in WRDA 96 based on an estimate we provided at your request. The updated estimate reflected the effort necessary to repair the breach. Our Environmental Assessment, in accordance with NEPA, found no significant impact from repair activity. Several important matters were resolved at this time including: compensatory storage for that storage lost by replacement of the wooden crib, architectural treatments to address historic preservation concerns, and agreement to postpone sampling of sediments behind the Dam until construction.

There may be a need for non-Federal attention to elements of the Allendale Dam not within the scope, or funds available, of the Federal Project. These include maintenance of the earth embankment and the gated sluiceway. The non-Federal owners of the Dam will be made aware of all their future maintenance responsibilities.

We were prepared to process a Decision Document (Letter Report) for approval to act as the basis for a Project Cooperation Agreement (PCA) between the Corps and the non-Federal sponsor when we were alerted by EPA to possible contamination of sediments behind the Dam. The Rhode Island DEM has requested we postpone approval of the project until they conduct a Risk Assessment and make recommendations accordingly. Any required cleanup of contamination by hazardous materials would be the responsibility of the non-Federal sponsor in accordance with standard provisions of the PCA.

Upon receipt of RI DEM's recommendations, we will coordinate with your staff as to our course of action. If cleanup of contamination is required, an estimate of this cost for non-Federal financing purposes will be prepared. SEC. 345. SOUTH CENTRAL PENNSYLVANIA

(a) COST SHARING.—Section 313(d)(3)(A) of the Water Resources Development Act of 1992 (106 Stat. 4846) is amended to read as follows:

"(A) IN GENERAL.—Total project costs under each local cooperation agreement entered into under this subsection shall be shared at 75 percent Federal and 25 percent non-Federal. The Federal share may be provided in the form of grants or reimbursements of project costs. The non-Federal interests shall receive credit—

"(i) for design and construction services and other in-kind work, whether occurring subsequent to, or within 6 years prior to, entering into an agreement with the Secretary; and

"(ii) for grants and the value of work performed on behalf of such interests by State and local agencies, as determined by the Secretary."

(b) AUTHORIZATION OF APPROPRIATIONS.—Section 313(g)(1) of such Act (106 Stat. 4846) is amended by striking "\$50,000,000" and inserting "\$80,000,000".

(c) SECTION HEADING.—The heading to section 313 of such Act is amended to read as follows:

SEC. 313. SOUTH CENTRAL PENNSYLVANIA ENVIRONMENT IMPROVE- MENT PROGRAM."

SEC. 346. WYOMING VALLEY, PENNSYLVANIA

The project for flood control, Wyoming Valley, Pennsylvania, authorized by section 401(a) of the Water Resources Development Act of 1986 (100 Stat. 4124), is modified to authorize the Secretary—

(1) to include as part of the construction of the project mechanical and electrical upgrades to stormwater pumping stations in the Wyoming Valley; and

(2) to carry out mitigation measures that the Secretary would otherwise be authorized to carry out, but for the General Design Memorandum for phase II of the project, as approved by the Assistant Secretary of the Army having responsibility for civil works on February 15, 1996, providing that such measures are to be carried out for credit by the non-Federal interest.

SEC. 347. ALLENDALE DAM, NORTH PROVIDENCE, RHODE ISLAND.

The project for reconstruction of the Allendale Dam, North Providence, Rhode Island, authorized by section 358 of the Water Resources Development Act of 1992 (106 Stat. 4861), is modified to authorize the Secretary to reconstruct the dam, at a total cost of \$350,000, with an estimated Federal cost of \$262,500 and an estimated non-Federal cost of \$87,500.

SEC. 348. MARRAGANSETT, RHODE ISLAND.

Section 361(a) of the Water Resources Development Act of 1992 (106 Stat. 4861) is amended—

(1) by striking "\$200,000" and inserting "\$1,900,000";

(2) by striking "\$150,000" and inserting "\$1,425,000"; and

(3) by striking "\$50,000" and inserting "\$475,000".
