It was a pleasure speaking with you today about the archeological work that has been performed to date in connection with the state enhanced remedy at the New Bedford Harbor site. In our conversation, we confirmed

that you will send ME DEP's January 18, 2012 submission to the State Historic Preservation Officer for review and comment. It is also my understanding that the archeological work performed to date, which is described in the 1/18/12 submission, was previously submitted to the SHPO, although you are uncertain whether the 1/18/12 submission itself was transmitted to the SHPO. It is also my understanding that the scope of the archeological work performed to date encompasses the footprint of the SER as described in the 1/18/12 submission.
