Here is what has been raised so far:

1. Could you more specifically address how the South Terminal Project is substantively compliant with the Wetland, Waterway, and Water Quality regulations. The letter appears to state that the South Terminal Project is exempt from many of the required performance standards, since the project will "improve the natural capacity of wetlands or any other water of the Commonwealth". The justification for this exemption is confusing.
2. In addition, specific conditions (e.g. construction sampling methodology, time-of-year restrictions, the establishment of mixing zones, the use of silt curtains and environmental dredge buckets, real time dredge and dewatering turbidity monitoring and response plan and environmental monitors' oversight) appear to be imposed to make sure that construction is compliant with State regulatory authorities. Is MassDEP planning on issuing a water quality certification for the South Terminal project? Alternatively would the Commonwealth issues these conditions in a separate state ARARs document?
3. Is this the complete universe of State ARARs that you plan to identify?

There may be other questions, but that's what we have so far.
