History: This message has been replied to and forwarded.

Hi Ann,

Apex was reviewing the South Terminal document and noted some discrepancies in the resource area numbers that we wanted to alert you to immediately:

There are three numbers that are wrong, primarily on page 2 of the document (although one of the errors is repeated two other times within the document).

The number of acres of shallow, near-shore, sub-tidal area that will be dredged from -1 to -12 MLLW to -14 MLLW, and is listed as "7.71" acres should be "8.46" acres. This is an addition error and this is the only location in the document that this number is wrong. Other locations have this number broken into its components, and those numbers are correct.

Also on Page 2: The size of the CAD Cell is listed as "8.67" acres, but should be "8.76" acres. This error is repeated on pages 132 and 144 of the document. This was a transposition error that was made during editing of the document and was therefore carried to several locations.

Also on Page 2: The number of acres maintenance dredging within the Federal Navigational Project is listed as "19.15" acres, and should be "19.6" acres. This number was used correctly throughout the document and this is the only location in the document that this number is wrong.

Apex regrets the errors. Could you please give us guidance as to how you would like us to handle the corrections?

Gary,

During the course of reviewing Phil's numbers, Apex realized that the resource impact numbers were not carried over correctly from the body of the document to the Executive Summary of the document (but appear to be consistent throughout the rest of the document).

There are three numbers that are wrong, all on page 2 of the document. "7.71" should be "8.46", "8.67 should be "8.76" and "19.15" should be "19.6". All of these numbers only appear once on this page.

We should alert EPA to this discrepancy. With your permission, I will contact Ann Williams for direction.
