Dear Bettina and Chuckie:

In keeping with our previously established arrangement, please be advised that the Commonwealth needs to collect some additional vibracores (probably just one day of work) within the South Terminal project area. The vibracores are being advanced to collect environmental samples. They are typically collected using a vibrating core barrel, which is advanced through the subsurface. The core is brought to the surface typically intact (depending on recovery). We plan on advancing six of these vibracores at the attached location. While we are flexible on when we can perform the work, we would certainly like to complete this work within the next few weeks. Please let me know who you propose to observe this activity, their contact information and their availability. From there, we will reach out to your representatives and arrange a mutually agreeable date.
