Please join Hands Across the River on Wednesday, April 11 at 6:00 p.m. for a conversation with representatives from the Massachusetts Office of Energy and Environmental Affairs (EEA) to discuss the Confined Disposal Facility project at the South Terminal in New Bedford. The state proposes to develop a multi-purpose marine terminal, a primary purpose of which will be to provide infrastructure to serve offshore renewable energy facilities and accommodate international shipping at the new facility. The proposed facility will re-use sand from navigational dredging or involve construction of confined aquatic disposal facilities to the extent approved by US EPA.

The conversation will begin with a presentation from EEA and its contractor, Apex Engineering, followed by an open question and answer session for residents to ask questions, raise concerns, suggest project changes, and learn about the proposed project.
