Hi Cindy,

Attached please find the updated Appendix S from the June 18, 2012 submission to EPA.

Please note that all of the volumes in the table are engineering estimates only.

Please note that a number of the estimated volumes have changed based on minor changes to the design and changes in the ultimate destination for some of the material that have taken place since the Draft Determination was issued.

These include: removal of the Stormwater Drainage Swale Mitigation Area, refinement of the easement areas, and some refinements on the estimates of volumes that would be generated from the potential expansions. Some of the refinements have resulted in a slight increase in the total volumetric number for the project. If you wish to discuss the source of these changes, we would be more than happy to explain.

As requested, we have broken out the individual expansion items, including the expansions to the north and south, the channel width expansion and the maintenance dredging in the Federal Channel and have shaded those for your reference.
