

Chet,

Just 2 quick comments on the Fish Deterrent Plan.

1. Figure 2 should include a depiction of where the Fish Weir Nets will be placed.
2. The monitoring plan makes reference to 1200 foot transects parallel to the shoreline, with their starting points randomly selected. This selection process needs to be more completely articulated. It appears that the project area is being gridded off and random numbers assigned to each square. Transects will then occur in each randomly selected square. Thus, the squares are 1200 feet in length? More detail on this process is needed and perhaps a figure depicting the grid and a hypothetical transect line.

Carl and Ann,

Attached please find the text for the Draft Final Mitigation Plan.

There are figures and appendices to go with it, but we were unable to finalize the report in time to hand deliver CDs with that material on them, and the figures and appendices are large, unfortunately.

Please note that the design of the River's End Park Mitigation Project is not complete. A conceptual plan is included in the appendices, a 90% design area estimate and estimate of proportional mitigation ratio is included in the document. Therefore, some of the numbers that still have some uncertainty (for example, the final area of that mitigation project) are highlighted in yellow and a range is given.

In addition, there are references to the final plans that we have not yet received. A resource delineation for that project is currently underway, and will be forwarded upon completion (the incomplete resource delineation is the source of uncertainty regarding the final area of the River's End Mitigation Project).

Unless someone is working on Monday (we will be working), we will deliver 10 CDs of the completed Draft Final Mitigation Plan to EPA on Tuesday morning.
