Re: Coverage for Shell Gulf of Mexico, Inc. to discharge from the *Noble Discoverer* exploratory facility under the National Pollutant Discharge Elimination System (NPDES) General Permit for Oil and Gas Exploration Facilities on the Outer Continental Shelf in the Chukchi Sea (Permit No. AKG-28-8100)

Dear Ms. Childs:

This letter provides the United States Environmental Protection Agency's (EPA) response to the Notice of Intent (NOI) application packages submitted by Shell Gulf of Mexico, Inc. (Shell) requesting permit coverage under the NPDES General Permit for Oil and Gas Exploration Facilities on the Outer Continental Shelf in the Chukchi Sea (Chukchi Sea General Permit).

On January 22 and 29, 2015, Shell submitted initial NOI applications requesting authorization to discharge wastewater to the Chukchi Sea from the *Noble Discoverer* exploratory facility at the Burger F, Burger J, Burger S and Burger V well sites. Shell submitted revised NOI applications on April 21, 2015. The EPA deemed the NOI applications complete on May 19, 2015.

Pursuant to Section I.C.3 of the Chukchi Sea General Permit, Shell is authorized to discharge the following waste streams from the *Noble Discoverer* exploratory facility into the Chukchi Sea at the four proposed well sites, subject to the terms and conditions of the General Permit.

The EPA has assigned unique permit numbers to the *Noble Discoverer* for each of the four proposed well sites, as identified in the following table. Please use the applicable NPDES permit numbers in all future correspondence and reporting.

Please note the Chukchi Sea General Permit imposes effluent limitations and monitoring requirements in Section II and monitoring, recording and reporting requirements in Section III. Discharge Monitoring Reports must be submitted monthly by the 20<sup>th</sup> day of the following month.

Facilities discharging under the authority of the Chukchi Sea General Permit must keep a copy of the permit and this coverage letter at the facility where the discharges occur, or retain a copy at the nearest administrative or field office managing the operation.

With this discharge authorization decision, the following permit coverages granted on June 23, 2011 under the NPDES General Permit for Oil and Gas Exploration Activities on the Outer Shelf and Contiguous State Waters for Discharges into the Chukchi and Beaufort Seas, Alaska (Arctic General Permit) are terminated:
