**NOTICE OF HEARING ON TRUSTEE'S EMERGENCY MOTIONS
TO ASSUME EXECUTORY CONTRACTS**

YOU ARE HEREBY NOTIFIED that Thomas A. Krudy, in his capacity as Chapter 7 Trustee of the Estate of ESI Environmental, Inc. (the "Trustee") has filed the following Motions (the "Motions"):

1. An "Emergency Motion to Assume Executory Contracts with Chartis Specialty Lines Insurance Company" seeking authorization to assume certain insurance contracts and other agreements previously entered between the Debtor, ESI Environmental, Inc. ("ESI") and American International Specialty Lines Insurance Company n/k/a Chartis Specialty Lines Insurance Company (AISLIC) relating to the remediation of toxic wastes at ESI's Indianapolis processing facility and AISLIC's agreement to pay the costs thereof;

2. An "Emergency Motion to Assume Executory Contract with WSP Environmental & Energy" (the "Motion") seeking authorization to assume a certain contract between WSP Environmental & Energy ("WSP") and the Debtor, ESI Environmental, Inc. ("ESI") engaging WSP to treat, remove, and/or remediate toxic wastes located at ESI's Indianapolis, Indiana processing facility pursuant to a remediation plan previously approved by the U.S. Environmental Protection Agency and the Indiana Dept. of Environmental Management; and

3. An "Emergency Motion to Assume Executory Contract with National Union Fire Insurance Company of Pittsburg, PA seeking authorization to assume a certain first party property insurance contract between National Union Fire Insurance Company of Pittsburg, PA and the Debtor, ESI Environmental, Inc. ("ESI").

YOU ARE FURTHER NOTIFIED that a hearing on the Trustee's Motion will be held on November 10, 2010 at 9:30 A.M. E.S.T. (the "Hearing Date") in Room 329 at the U.S. Courthouse, 46 East Ohio Street, Indianapolis, IN 46204
